REGIONAL REGULATION ON COMPANY COMPULSORY REGISTRARATION

- ABSTRAK :
- That in order to support the development of the business world it is necessary to create a healthy business climate with the availability of a list of companies as an official source of information for all interested parties regarding the identity and matters relating to companies established in the Regions. That in accordance with Law Number 28 of 2009 concerning Regional Taxes and Regional Levies, Company Registration is not one of the objects of regional levies. That in connection with the enactment of the Regulation of the Minister of Trade Number 37/M-DAG/PER/2/2007 concerning the Implementation of Company Registration as amended several times, the latest by the Regulation of the Minister of Trade Number 08/M-DAG/PER/2/2017 concerning the Second Amendment to the Regulation Minister of Trade Number 37/M-DAG/PER/2/2007 concerning the Implementation of Company Registration, it is deemed necessary to review Regional Regulation Number 3 of 2004 concerning Compulsory Company Registration.
 - The legal basis fir this Regional Regulation is : Article 18 section (6) of the 1945 Constituion of the Republic Indonesia; Law Number 13 of 1950; Law Number 67 of 1958; Law Number 8 of 1981; Law Number 3 of 1982; Law Number 25 of 1992; Law Number 25 of 2007; Law Number 40 of 2007; Law Number 14 of 2008; Law Number 20 of 2008; Law Number 25 of 2009; Law Number 28 of 2009; Law Number 7 of 2014; Law Number 23 of 2014 as has been amended several times, most recently by Law Number 9 of 2015; Law Number 30 of 2014; Government Regulation Number 16 of 1976; Government Regulation Number 27 of 1983 as amended by Government Regulation Number 58 of 2010; Government Regulation number 69 of 1992; Government Regulation Number 24 of 2018; Presidential Regulation Number 97 of 2014; Presidential Regulation Number 91 of 2017; Presidential Regulation Number 16 of 2018; Regulation of the Regency Semarang Level II Number 10 of 1988; Regulation of the Regency Semarang Number 21 of 2016.
 - In this Regional Regulation, it is regulated about : General Provisios; Object And Subject; Registration Obligations And Exclusions; Company Registration Procedures; Authorities, Duties, Responsibilities And Reporting; Validity Period TDP; Cost; Administrative Sanctions; Guidance And Supervision; Provisions Of Investigation; Criminal Provisions; Transitional Provisions; Closing Provisions.
